National Legal Services Day date also holds a special meaning as the Indian Legal Services Authorities Act 1987 came into effect on November 9, 1995. Since then National Legal Services Day date is November 9 and the day is observed every year. The National Legal Services Authority, NALSA was constituted under the Indian Legal Services Authorities Act 1987. This was done to provide free legal services to the weaker sections of the society. They were to organize Lok Adalats for the amicable settlement of disputes. The day is also celebrated to make people aware of various provisions under the Legal Services Authorities Act and the right of the litigants.

Prof. K.B Vasudeva Director of Legal Studies in his presidential address mentioned about the, significance of Legal Service Day. A lot of people think of legal proceedings as a time consuming and a messy
